1. This Form must be completed and signed by the individual who was the registrant of the Domain prior to the Domain's deletion (such individual hereinafter referred to as the "Current Registrant"). If the Current Registrant is a company, an authorized representative who has signing authority for the Current Registrant Company must complete this form.
2. If the Current Registrant is an individual, a copy of valid, government-issued picture identification is required and must be attached to this Form.
3. If the Current Registrant is a company, this Form must be attached to a cover letter on company stationary or letterhead. The cover letter AND this Form must be signed by an authorised representative of the Current Registrant company.
4. The information submitted in this Form must be true, accurate and complete.
